

THENCE, departing the west line of said 3.224 acre tract of land, South 86 degrees, 24 minutes, 44 seconds West, a distance of 199.99 feet to a 3" metal fence post; being

FHENCE, South 00 degrees, 02 minutes, 16 seconds West, a distance of 299.48 feet to 1/2" iron rod found; being the southwest corner of a said tract of land conveyed to Mack Spence & Glenda Spence and the southeast corner of the said acre 26.459 tract of land; and in the said north right of way line of West Main Street;
